

ORDINANCE NO. 440N

AN ORDINANCE OF THE TOWN OF GARFIELD, WASHINGTON, amending Ordinance No.436N, hereby correcting the estimated general levy to be collected by the Town in Budget Year 2014.

The Town Council of the Town of Garfield has met and considered its budget for the calendar year 2013; and the town's actual levy for the previous year was \$60,764.81; and the population of town is less than 10,000; and now, therefore,


BE IT ORDAINED by the Town Council of the Town of Garfield that Section 1 of Ordinance No 436N be and is hereby amended to read as follows:


"Section 1. The dollar amount of the increase over the actual levy amount from the previous year shall be \$883.60, which is an increase of one percent from the previous year, plus an increase of \$602.38 which is an increase of approximately one percent from the previous year, due to banked capacity and an increase of approximately \$316.00 due to new construction. This increase is exclusive of additional revenue resulting from new construction allowed under the provisions of RCW 84.55.010, plus improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made."

Section 2. This ordinance shall be in full force and effect five days after it or a summary thereof, is published in the official newspaper of the Town of Garfield as required by law.
