Tami Southern MOVED to approve the Conditional Use Permit # CUP2014-01 granting the conditional use permit to conduct a marijuana processing operation on the premises of 109 S. 10th Street, Garfield, Washington with the following conditions:

- If any time during any given 12-month period three or more separate incidents of unlawful activity occur on the property which are related in any manner to the processing of marijuana or the storage of marijuana for processing thereon, the Board of Adjustment shall reconvene to consider revocation of the Conditional Use Permit.
- If any wastewater entering the municipal wastewater collection system from the marijuana processing operation is found to contain any compounds which are harmful to the operation of the municipal wastewater treatment facility, the Board of Adjustment shall reconvene to consider revocation of the Conditional Use Permit.
- 3. If any waste or chemical residue originating from the marijuana processing operation is found in the municipal compost site or in any garbage collected (or placed for collection) by the municipal garbage collection system, the Board of Adjustment shall reconvene to consider revocation of the conditional use permit.

Kevin Pickron seconded the motion and the motion carried unanimously.
